SYNOPSIS OF LEGISLATIVE COUNCIL LEGISLATION

ANIMAL WELFARE (JUMPS RACING) AMENDMENT

The purpose of this Bill is to amend the *Animal Welfare Act 1985* to prohibit jumps racing.

(1 August 2018; lapsed due to prorogation)

ASSISTED REPRODUCTIVE TREATMENT (REVIEW RECOMMENDATIONS) AMENDMENT

The purpose of the Bill is to amend the *Assisted Reproductive Treatment Act 1988* to establish a donor conception register.

(5 December 2018, 16 October 2019; Bill withdrawn in House of Assembly)

AUTOMATED EXTERNAL DEFIBRILLATORS (PUBLIC ACCESS)

The purpose of this Bill is to require the installation and registration of Automated External Defibrillators in certain buildings, facilities and vehicles.

(16 October 2019; lapsed due to prorogation)

CIVIL LIABILITY (BYO CONTAINERS-WASTE AVOIDANCE) AMENDMENT

The purpose of this Bill is to amend the *Civil Liability Act 1936* so that a person who sells food or beverages to a customer in the customer's own container incurs no civil liability for loss of life or personal injury arising from consumption of the food or beverage so sold unless -

- the person knew or was recklessly indifferent to the fact that it was unsafe within the meaning of the *Food Act 2001*; or
- the food or beverage was the subject of a product safety 5 recall published on the ACCC website.

(25 July 2018; lapsed due to prorogation)

CONTROLLED SUBSTANCES (YOUTH TREATMENT ORDERS) AMENDMENT

This Bill amends the *Controlled Substances Act 1984* to permit an application to be made to the Youth Court for a series of orders in relation to a child or young person under the age of 18 years with a drug dependency. Applicants may be family members or certain other interested persons, namely: a person prosecuting the respondent for an offence; officers involved in youth corrections and/or child protection; a medical practitioner providing treatment to the respondent in relation to their drug use. The Youth Court itself may also make orders on its own motion if there are proceedings before the Court involving the respondent.

The Bill anticipates that the Court would first make an assessment order requiring a respondent to attend at a nominated assessment service. To make an assessment, the Court would need to be satisfied that there is a reasonable likelihood that the respondent is habitually using one or more controlled drugs and that the respondent may be a danger to himself or herself or to others and that the respondent is unlikely to voluntarily seek a relevant assessment. The assessment service will be required to report to the applicant and to the Court following its assessment.

If the respondent has failed to comply with an assessment or treatment order, the Court may make a detention order authorising the detention of the respondent for the purpose of ensuring compliance with the relevant order. The Court will only be able to make an assessment, treatment or detention order in relation to a person under the

age of 18 years. However, an order for assessment or treatment will continue to have effect after the respondent reaches the age of 18 years, subject to a contrary order by the Court. An order made by the Court can only operate for a maximum of 12 months.

To provide guidance to the Court, assessment services and others involved in the implementation of these reforms, the Bill provides that the question of dependency on controlled drugs is to be determined by reference to diagnostic criteria for a dependence syndrome published by the World Health Organization.

(21 June, 15 November, 6 December 2018, 14 May, 20 June, 2 July, 14 November 2019; Act No. 26 of 2019)

COORONG ENVIRONMENTAL TRUST

The purpose of the Bill is to establish the Coorong Environmental Trust, to provide for the administration of the Trust and for other purposes.

(3 April, 31 July 2019 - referred to a Select Committee; 15 October - Report brought up, 17 October 2019; lapsed due to prorogation in House of Assembly)

CORONERS (MISCELLANEOUS) AMENDMENT

The purpose of this Bill is to amend the *Coroners Act 2003* to clarify the jurisdiction of the Coroners Court; provide for legal representation for families of the person to whom the Coroner's proceedings relate and that reasonable costs for that representation are met by the Crown; separate legal professional privilege from privilege against self-incrimination and make new provisions for the court to issue a certificate providing indemnity from self-incrimination in certain circumstances; clarify the findings on inquest that the Coroners Court can make; and improve the accountability and transparency of government in respect to the recommendations made by the Coroner.

(19 June 2019; lapsed due to prorogation)

CRIMINAL LAW CONSOLIDATION (CHILD-LIKE SEX DOLLS PROHIBITION) AMENDMENT

This Bill seeks to ban the production, dissemination and possession of child-like sex dolls. These dolls are three dimensional, resemble children and have imitation orifices that are intended to be used for simulating sexual intercourse.

The Bill is similar to relevant provisions in the Commonwealth *Combatting Child Sexual Exploitation Amendment Bill 2019*, which was introduced on 24 July 2019.

The South Australian Bill seeks to amend Division 11A of the *Criminal Law Consolidation Act 1935*, which creates offences relating to child exploitation material. The Bill would put it beyond doubt that the child-like sex dolls fall within the definition of child exploitation material.

(15 May, 11 September 2019; Act No. 26 of 2019)

CRIMINAL LAW CONSOLIDATION (DOMESTIC ABUSE) AMENDMENT

The purpose of this Bill is to amend the *Criminal Law Consolidation Act 1935* to create a new offence against controlling or coercive behaviour in a relationship.

(17 October 2018; lapsed due to prorogation)

DISABILITY INCLUSION

This Bill aims to promote human rights and improve inclusion in the community for South Australians with disability. In the context of the major reforms flowing from implementation of the National Disability Insurance Scheme (NDIS), the Bill seeks to clarify South Australia's role in supporting people with disability, as responsibility for disability services and support is transferred from State Governments to the Commonwealth and the National Disability Insurance Agency (NDIA).

The Disability Services Act 1993 will not be required once transition to the NDIS is fully realised because the State Government will no longer directly fund services. Instead, the NDIA will work with eligible individuals to create a personal budget to pay for their chosen services and supports, based on their goals.

The Bill is underpinned by a range of rights-based principles, recognising that whilst people with disability have the same fundamental human rights as others, they often experience difficulty exercising their rights because of the inaccessibility of things such as built form, cultural approaches or other limitations. Through these principles, the Bill gives visibility to the issues faced by people with disability.

The overall purpose of the Bill is to ensure these issues are considered and the views of people with disability are incorporated into policies and programs that affect them. The Bill also articulates a range of rights specific to certain groups who can face additional challenges and vulnerabilities. This includes women with disability, children with disability, Aboriginal and Torres Strait Islander people with disability and culturally and linguistically diverse people with disability. The principles will be brought to life through disability inclusion planning, which is another key feature of the Bill.

Under the Bill, a state disability inclusion plan will be developed every four years. There is also a requirement for state government departments, statutory authorities and local councils to develop and implement a disability access and inclusion plan (DAIP) every four years. The Bill also includes the ability to make regulations for a community visitor scheme (CVS).

The Bill enables the drafting of general regulations that may include any measures to fill gaps that emerge as implementation of the NDIS continues; in particular, elements of the national Quality and Safeguarding Framework.

(9, 29, 30, 31 May, 5 June 2018; Act No. 1 of 2018)

FIRE AND EMERGENCY SERVICES (VOLUNTEER CHARTERS) AMENDMENT

This Bill gives legislative recognition to the Volunteer Charters of the South Australian Country Fire Service and the South Australian State Emergency Service. These Charters currently sit in the regulations. This Bill lifts them into legislation. It does so by amending the Fire and Emergency Services Act 2005, inserting new sections which establish Parliamentary recognition of the Charters.

The legislation will cover the approximately 14,000 CFS volunteers and 1,600 SES volunteers from whom South Australia currently enjoys a service.

The first paragraphs of both Charters read: "The Government of South Australia supports and recognises the role that emergency service volunteers play in our community."

This Bill aims to demonstrate support for these volunteers through enshrining these Charters in legislation.

(16 May 2018, 5 June 2019; Act No. 20 of 2019)

FREEDOM OF INFORMATION (MISCELLANEOUS) AMENDMENT

This Bill seeks to amend the *Freedom of Information Act 1991* to introduce a reference to the principles of representative democracy in the objects section of the Act and also to acknowledge that documents held by government are 'a public resource to be held on behalf of the public and managed for public purposes'.

(9 May, 4 July, 18 October 2018; lapsed due to prorogation in House of Assembly)

GAMING MACHINES (PROHIBITION OF EFTPOS FACILITIES) AMENDMENT

The purpose of this Bill is to amend the Gaming Machines Act 1992 to remove EFTPOS facilities from gaming areas.

(1 August 2018; lapsed due to prorogation)

GENETICALLY MODIFIED CROPS MANAGEMENT (DESIGNATION OF AREAS) AMENDMENT

The purpose of this Bill is to amend the *Genetically Modified Crops Management Act 2004* to ensure that until 1 September 2025, the whole of the State is, designated as an area in which no genetically modified food crops may be cultivated.

(25 September 2019; lapsed due to prorogation)

HEALTH AND COMMUNITY SERVICES COMPLAINTS (MISCELLANEOUS) AMENDMENT

The *Health and Community Services Complaints Act 2004* provides oversight of unregistered practitioners that the Australian Health Practitioner Regulation Agency does not cover. The aim of the Act is to protect the health and safety of the public.

This Bill will amend the Act so that the National Code of Conduct for Health Care Workers, approved by the COAG Health Council for adoption by the States and Territories, will replace the Code of Conduct for Unregistered Health Practitioners (South Australian Code) which is currently in operation.

The National Code will be, or has been, adopted by all States and Territories so that a nationally consistent approach is taken and that Orders from one jurisdiction will be enforceable in another.

(18 October, 6, 13 November 2018; Act No. 37 of 2018)

HEALTH CARE (GOVERNANCE)

This Bill aims to devolve decision-making in the public health system through the establishment of metropolitan and regional governing boards; put responsibility and accountability at the local level; strengthen oversight; improve patient safety; and hold governing boards accountable for delivering progress.

Health care reform will be implemented in two stages. The first stage is this amendment Bill to establish governing boards. It will allow governing board chairs to be appointed from 31 July 2018, with governing boards becoming fully operational by 1 July 2019. The second stage will be to establish a new governance and accountability framework for the public health system, which will be provided for in future legislation.

Governing boards will be responsible for the delivery of local health services within their geographic area. Each board must, as far as practicable, be comprised of a membership with experience across a range of skills, including provision of health services, law, finance, clinical governance and Aboriginal health. The governing boards will consult with local service providers and the community to ensure that the services are reflective of local priorities. The governing boards will also be responsible for the oversight of local health network budgets. The governing boards will each appoint their chief executive officer, who will be responsible for managing the operations and affairs of the local health network health services and be accountable to and subject to direction of the governing board. Further, governing boards must demonstrate their annual progress against a set of performance indicators. Governing boards will be established for each of the local health networks as they are currently constituted, except for Country Health SA. In country SA, six new regional incorporated hospitals will be established, based on the current regional boundaries operated by the Country Health SA Local Health Network. They will take over the functions of providing health services for their particular areas from Country Health SA Local Health Network from 1 July 2019.

In the event that a governing board has failed to perform its functions effectively, meet a provision of the Act or comply with the direction given by the Minister or the Chief Executive of the Department, the Minister will have the ability to dismiss the governing board and appoint an administrator.

(7 June, 3, 4, 5, 26 July 2018; Act No. 8 of 2018)

HEALTH CARE (HEALTH ACCESS ZONES) AMENDMENT

The purpose of this Bill is to amend the *Health Care Act 2008* to establish health access zones to provide protection for abortion care.

(25 September, 30 October, 14 November 2019; lapsed due to prorogation in House of Assembly)

LATE PAYMENT OF GOVERNMENT DEBTS (INTEREST) (AUTOMATIC PAYMENT OF INTEREST) AMENDMENT

The purpose of this Bill is to expand the *Late Payment of Government Debts (Interest) Act 2013* to cover all businesses trading in the public sector and enable the automatic payment of interest on overdue accounts where certain criteria are met. The key changes to the existing Act as set out in the Bill are:

expanding the scope to cover all businesses trading with the Government rather than the current limitation to small business;
reducing the minimum interest payment threshold from \$20 to \$10;
limiting application of the Act to invoices with a value of \$1 million or less; and
automating the payment of interest to business such that it occurs at the same time the overdue invoice is paid in accordance with the Government's standard 30-day payment terms.

The Act will cover all public authorities as defined under the Public Audit and Finance Act 1987, brought under this definition through notice published in the Government Gazette. The Small Business Commissioner will continue to retain a dispute resolution function under the Act.

(26 July, 18 September 2018; Act No. 19 of 2018)

LIMITATION OF ACTIONS (ACTIONS FOR CHILD ABUSE) AMENDMENT

The purpose of this Bill is to amend the *Limitation of Actions Act 1936* to allow survivors of child abuse to sue churches, schools and other institutions that previously forced them into unfair and unjust financial settlements.

(19 June 2019; lapsed due to prorogation)

LOCAL GOVERNMENT (DIFFERENTIAL RATES ON VACANT LAND) AMENDMENT

The purpose of this Bill is to amend the *Local Government Act 1999* to prohibit the declaration of differential rates that exceed the rate that would have been imposed were the land being used for residential purposes unless the land has been owned by the same person or body for not less than three years.

(1 August, 29 November 2018; Bill negatived at Second Reading)

LOCAL GOVERNMENT (FIXED CHARGES) AMENDMENT

The purpose of this Bill is to amend the *Local Government Act 1999* to not allow councils power to charge a minimum rate for an individual unit in a retirement village.

(17 October 2018; lapsed due to prorogation)

LOCAL GOVERNMENT (RATEPAYER PROTECTION AND RELATED MEASURES) AMENDMENT

The purpose of the Bill is to amend the to amend the *Local Government Act 1999* to provide greater ratepayer oversight of council budgeting, greater disclosure of council expenses and performance and greater and more effective consultation between councils and ratepayers. Further it requires all Councils to disclose all member and staff credit card use, all council-funded gifts received by members and staff, and all non-land-based interstate and overseas member and staff travel.

The Bill will also require any new council project valued at \$1 million or more and any new service valued at half a million dollars or more, calculated for the life of the service, to have a rate impact statement.

(24 October 2018, 14 November 2018; Bill negated at second reading in House of Assembly)

MOTOR VEHICLES (COMPULSORY THIRD PARTY INSURANCE) AMENDMENT

The Compulsory Third Party (CTP) scheme is transitioning to a market-based competition model. The competition model will begin on 1 July 2019 and apply to CTP insurance policies which commence from 1 July 2019. Since 1 July 2016, motorists' CTP insurance policies have been automatically allocated to approved insurers. This auto-allocation will no longer apply after the expiry of the transitional period on 30 June 2019.

This Bill will enable the continuation of auto-allocation for new vehicle CTP policies after the commencement of the competition model. The auto-allocation will occur based on a scheme determined by the Minister rather than enshrined in the legislation.

The proposed scheme will allocate new vehicle policies according to approved insurer market share at the lowest premium price offered for the premium class by any of the approved insurers at the time of allocation. Auto-allocation will not apply to renewal of CTP insurance policies.

The continuation of auto-allocation for new vehicle policies will remove the possibility of commissions and inducements being offered by insurers to motor vehicle dealers to acquire CTP business where there is no direct benefit to the motorist.

Motorists will not be disadvantaged by the removal of choice at point of sale as they will be able to nominate an alternative insurer within the first three months of the new policy, with that nomination taking effect at the fourth month of the policy.

(28 February, 2, 4 April 2019; Act No. 5 of 2019)

OFFICE FOR THE AGEING (ADULT SAFEGUARDING) AMENDMENT

This Bill establishes a new adult safeguarding unit, which will be located in the Office for Ageing Well within the Department for Health and Wellbeing. The unit will aim to complement the role of police and other government and non-government agencies by providing the South Australian community with an approachable, empowered body, with statutory responsibility and accountability for responding to reports of abuse or neglect of vulnerable adults.

A key focus of the unit will be on the prevention of abuse through awareness raising and community education. But where reports of alleged or suspected abuse are received, the unit will be responsible for assessing and investigating these reports. The Bill empowers authorised officers with a range of coercive information-gathering powers to enable them to effectively investigate reports of serious abuse, such as the power to require a person to answer questions and produce documents.

The Bill provides for the director of the adult safeguarding unit to apply to the court for an order in circumstances where there is reasonable suspicion that a vulnerable adult is suffering abuse. The legislation and operation of the unit will be further supported by a charter of the rights and freedoms of vulnerable adults, which will be developed in consultation with vulnerable adults, their carers and families.

The safeguarding provisions will apply to vulnerable adults aged 65 years or older, or 50 years or older for Aboriginal or Torres Strait Islander people.

In the interests of transparency and accountability, a person who is aggrieved by a decision made in relation to the safeguarding of a vulnerable adult may seek to have this decision reviewed. This review will be undertaken by the Chief Executive in the first instance, with the option of an external review by the Ombudsman available as a secondary step in cases relating to serious abuse.

Finally, the Bill provides for an independent review of the Act to be undertaken within its first three years of operation to ensure that the legislation is meeting the needs and expectations of the South Australian community.

(20 June, 6, 19 September, 18, 23 October 2018; Act No. 34 of 2018)

PARLIAMENTARY REMUNERATION (BASIC SALARY) AMENDMENT

The purpose of this Bill is to amend the *Parliamentary Remuneration Act 1990* by deleting the section connecting the salary of Members of Parliament with the Commonwealth basic salary and substituting a section providing that the salary is set by the state Remuneration Tribunal and confirmed by regulation.

(20 June 2018, 1 August 2018 - Bill negated at second reading)

PETROLEUM AND GEOTHERMAL ENERGY (MORATORIUM ON HYDRAULIC FRACTURING) AMENDMENT

The purpose of this Bill is to amend the *Petroleum and Geothermal Energy Act 2000* to prohibit hydraulic fracturing in the South East of South Australia.

(6 June, 25 July 2018 - Bill negated at second reading)

PETROLEUM AND GEOTHERMAL ENERGY (UNDERGROUND COAL GASIFICATION) AMENDMENT

The purpose of this Bill is to amend the *Petroleum and Geothermal Energy Act 2000* to prohibit underground coal gasification.

(6 June 2018; lapsed due to prorogation)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (CODE AMENDMENTS) AMENDMENT

The purpose of the Bill is to amend the *Planning, Development and Infrastructure Act 2016* by deleting the requirement for more than half of the affected property owners to agree before any historic conservation zones, or similar can be created.

(27 February, 3 July 2019; lapsed due to prorogation in House of Assembly)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (COMMENCEMENT OF CODE) AMENDMENT

The purpose of this Bill is to amend the *Planning, Development and Infrastructure Act 2016* to postpone the introduction of the Planning and Design Code for South Australia from 1 July 2020 to “the designated day”.

(13 November, 4 December 2019; lapsed due to prorogation in House of Assembly)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (GAS INFRASTRUCTURE) AMENDMENT

The purpose of the Bill is to amend the *Planning, Development and Infrastructure Act 2016*, by removing the requirement to connect gas infrastructure in certain new housing developments.

(24 October 2018; lapsed due to prorogation)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (RESERVES) AMENDMENT

The purpose of this Bill is to amend the *Planning, Development and Infrastructure Act 2016* to ensure that approved management plans for parks and reserves under the National Parks and Wildlife Act are automatically incorporated into the Planning and Design Code and ensure that all private developments proposed for national parks and other reserves under the National Parks and Wildlife Act will be subject to full public notification, representation and appeal rights.

(3 July, 16 October 2019; lapsed due to prorogation in House of Assembly)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (TRANSPARENCY) AMENDMENT

The purpose of this Bill is to amend the *Planning, Development and Infrastructure Act 2016* to limit the ability of the State Commission Assessment Panel (SCAP) to meet and deliberate in confidence to the same exemptive criteria as presently applies to council assessment panels and to require members of the SCAP to be professionally accredited to the same standards as already apply to members of council assessment panels under the Accredited Professionals Scheme.

(30 October, 27 November 2019; lapsed due to prorogation in House of Assembly)

PUBLIC FINANCE AND AUDIT (MISCELLANEOUS) AMENDMENT

This Bill proposes to improve timeliness and effectiveness of reporting by the Auditor-General and to simplify publication and administration. Currently, reports of the Auditor-General must be tabled on the next sitting day, and then only after the report is tabled can the report be published. This Bill proposes to allow the Auditor-General to publish a report after it has been delivered to the President of the Legislative Council and the Speaker of the House of Assembly. If either the President or the Speaker is absent then the Bill proposes to allow a Clerk of the relevant House to receive a report on behalf of the President or the Speaker (as the case may be).

The effect of this amendment is that the Auditor-General will be able to publish a report regardless of whether the Parliament is sitting or not. This addresses a key concern of the Auditor-General documented in his annual report tabled in Parliament on 17 October 2017.

This Bill also proposes a number of simplification measures. The first measure will allow the Auditor-General to annex documents to his report, which will reduce the burden of publishing his annual report to Parliament which currently can be in excess of 3,000 pages. Under the proposed amendments, these annexures will be available to Parliament on a website determined by the Auditor-General.

The second measure will require the Auditor-General to publish, on a website, audited financial statements of public authorities and the financial statements of the administrative unit established to assist the Auditor-General. This is a significant accountability measure that ensures that all audited financial statements of public authorities will, for the first time, be available on a website determined by the Auditor-General.

The third measure will allow the Treasurer to delegate power under the Public Finance and Audit Act to open, close and maintain deposit, special deposit and imprest accounts. This administrative function is considered low risk and will enable more efficient administration to support machinery of government and other strategic decisions of government.

(4, 24 July; Act No. 10 of 2018)

PUBLIC SECTOR (FUNCTIONS AND RESOURCES AUDIT) AMENDMENT

This Bill inserts a new section into the *Public Sector Act 2009* requiring the Minister overseeing each administrative unit to undertake a review into their functions.

(25 July 2018; lapsed due to prorogation)

RESIDENTIAL TENANCIES (RENTING WITH PETS) AMENDMENT

The purpose of this Bill is to amend the *Residential Tenancies Act 1995* to ensure that if the landlord does not consent to the tenant's application for a pet or pets, the tenant can apply to SACAT and SACAT will consider the circumstances and make a ruling.

(16 October 2019; lapsed due to prorogation)

RETURN TO WORK (POST TRAUMATIC STRESS DISORDER) AMENDMENT

The purpose of this Bill is to amend the *Return to Work Act 2014* so that a worker who has been employed as a first responder is diagnosed with post-traumatic stress disorder, the disorder is presumed, in the absence of proof to the contrary, to have arisen from employment.

(12 December 2019; lapsed due to prorogation)

SENTENCING (LIMITS ON HOME DETENTION) AMENDMENT

The purpose of the Bill is to amend the *Sentencing Act 2017* to remove the possibility of home detention for child sex offenders

(13 February 2019; lapsed due to prorogation)

SINGLE USE AND OTHER PLASTICS (WASTE AVOIDANCE)

The purpose of this Bill is to regulate the sale and supply of single use and other plastics.

(25 July 2018; lapsed due to prorogation)

SOCIAL WORKERS REGISTRATION

The purpose of this Bill is to make provision for the registration of social workers and to establish the social workers registration board with powers to investigate complaints and enforce penalties for practitioners who breach competency and ethical standards.

(5 September, 29 November 2018; Bill withdrawn and referred to a Joint Committee)

SOUTH AUSTRALIAN EMPLOYMENT TRIBUNAL (MISCELLANEOUS) AMENDMENT

The legislative amendments contained in this Bill relate to the exercise of the jurisdiction of the South Australian Employment Tribunal to hear Federal diversity jurisdiction matters and, secondly, to award compensation when convicting a person for a criminal offence.

The Bill addresses the constitutional issue raised in the recent High Court decision of *Burns v Corbett* [2018] HCA 15. That decision applies to prevent bodies that are not courts of the State from exercising Federal judicial power in relation to Federal diversity matters, namely those in which the Commonwealth, or a person suing or being sued on behalf of the Commonwealth, is a party; or between States, between residents of different States, or between a State and a resident of another State.

It follows from the High Court decision that the South Australian Employment Tribunal can only exercise jurisdiction to decide matters involving Federal diversity issues if the tribunal is a court of the State. However, the South Australian Employment Court is established under the South Australian Employment Tribunal Act 2014 as a part of the South Australian Employment Tribunal. The South Australian Employment Court is a court of the State and hence is capable of exercising Federal diversity jurisdiction. The Bill ensures that jurisdiction in relation to Federal diversity matters is directly vested in the South Australian Employment Court.

(18 September, 25 October, 6 November; Act No. 42 of 2018)

SOUTH AUSTRALIAN PUBLIC HEALTH (EARLY CHILDHOOD SERVICES AND IMMUNISATION) AMENDMENT

This Bill initiates a scheme which aims to improve the capacity of public health officers to prevent and control outbreaks of vaccine preventable diseases in early childhood services.

The Bill requires parents and guardians to provide immunisation records to their child's early childhood service and gives the Chief Public Health Officer the power to request those records. In the event of an outbreak of a vaccine preventable disease at an early childhood centre, the Bill will grant the Chief Public Health Officer the power to exclude a child from the centre. This will provide public health officers with more support to prevent and contain a dangerous outbreak.

(21 March, 4 April; Act No. 8 of 2019)

SOUTHERN STATE SUPERANNUATION (CHOICE OF FUND) AMENDMENT

The purpose of this Bill is to amend the *Southern State Superannuation Act 2009* to allow a member of the Triple S scheme to transfer their superannuation arrangements to a complying fund.

(5 September 2018; lapsed due to prorogation)

STATUTES AMENDMENT (ABORTION LAW REFORM)

The purpose of the Bill is to amend the *Criminal Law Consolidation Act 1935* and the *Health Care Act 2008* to remove abortion from South Australia's criminal laws; to remove a requirement that allows abortion only when the woman has resided in South Australia for two months; the requirement that all abortions must be performed in 'a prescribed hospital'; and create safe access zones.

(5 December 2018, 27 February 2019; lapsed due to prorogation)

STATUTES AMENDMENT AND REPEAL (SIMPLIFY)

This Bill aims to reduce red tape and simplify regulation for businesses and consumers.

Amendments to 40 Acts are contained within the Bill and 12 obsolete or unnecessary Acts are to be repealed. The remaining changes aim to support red tape reduction, most notably in relation to transport, licensing and registration.

Various amendments are made to the *Motor Vehicles Act 1959*, simplifying registration and licensing. The Bill will amend the *Road Traffic Act 1961* to allow low-risk public events to occur without the need for closing of public roads. Amendments to the *Aquaculture Act 2001* will extend the maximum production lease term that can be given from 20 to 30 years, with the aim of making the lease terms more attractive for financial institutions. The *Fisheries Management Act 2007* will be amended to give courts greater discretion over demerit points. The *Irrigation Act 2009* will be amended to facilitate new investment in South Australia's irrigated agriculture sector. The *Real Property Act 1886* will be amended to ensure the Registrar-General has the power to mandate electronic conveyancing in line with policy objectives. The *Dog Fence Act 1946* will be amended to reduce red tape by allowing the Minister to establish, vary the functions of, and abolish local dog fence boards by declaration. Provisions in the *National Parks and Wildlife Act 1972* will be clarified, relating to the appointment of the Director of National Parks and Wildlife.

The Bill includes amendments to various Acts providing the option to publish notices online. The public notices reforms aim to decrease the time and cost associated with public notices advertisement. Where it is considered the best option, publications of notices in newspapers will continue to play an important role, for example, in rural and remote communities where internet access is not always available.

(18 October 2018, 12, 26 February, 2 April 2019; Act No. 25 of 2019)

STATUTES AMENDMENT (ANIMAL WELFARE REFORMS)

The purpose of this Bill is to amend the *Animal Welfare Act 1985*, the *Dog and Cat Management Act 1995* and the *Criminal Law Consolidation Act 1935* to improve transparency and accountability when it comes to animal welfare.

(5 June 2019; lapsed due to prorogation)

STATUTES AMENDMENT (DECRIMINALISATION OF SEX WORK)

This Bill seeks to amend various pieces of legislation to decriminalise sex work and to provide sex workers the same rights and protections as other workers.

(9 May 2018, 5 June, 19, 20 June 2019; Negatived in House of Assembly)

STATUTES AMENDMENT (FREE MENSTRUAL HYGIENE PRODUCTS PILOT PROGRAM)

The purpose of this Bill is to amend the *Education Act 1972* and the *Education and Children's Services Act 2019* to enable the Minister to establish a program to trial the provision of free menstrual hygiene products to students in Government schools.

(27 November 2019; lapsed due to prorogation)

STATUTES AMENDMENT (MANDATORY REPORTING)

The purpose of this Bill is to amend the *Children and Young People (Safety) Act 2017* and the *Criminal Law Consolidation Act 1935* to ensure that if a priest or other minister of religion forms a suspicion, in the course of carrying out their duties (including in the course of a confession made in accordance with the rules and usages of the relevant religion), that a person has committed a prescribed child sex offence, that priest or minister must inform police of that suspicion.

(5 September 2018; lapsed due to prorogation)

STATUTES AMENDMENT (SCREENING)

The aim of this Bill is to strengthen measures preventing persons who pose a risk of harm from working with children and vulnerable people. To that end the Bill introduces a number of measures needed to implement policy directions and national agreements that have arisen since the introduction of the *Child Safety (Prohibited Persons) Act 2016* and the *Disability Inclusion Act 2018*. In preparation for the commencement of this new scheme, this Bill amends various Acts to achieve the following:

- Abolishing fees payable for volunteers who work with children or vulnerable people
- Meeting nationally agreed obligations regarding working with children screening
- Establishing a scheme for NDIS worker screening
- Standardising and simplifying screening

(14 February, 4, 30 April; Act No. 9 of 2019)

STATUTES AMENDMENT (SOUTH EASTERN FREEWAY OFFENCES)

In November 2017, two new offences and associated penalties were introduced applying to trucks and buses on the South Eastern Freeway descent into Adelaide. The offences and penalties came into operation on 1 May 2019. This Bill seeks to address concerns regarding the severity of the penalties as they have been imposed.

The offences and penalties were implemented in response to recommendations from a Coronial Inquest following repeated crashes involving out of control heavy vehicles that resulted in the loss of lives and serious injuries.

The first offence was for exceeding the relevant speed by 10 kilometres or more, and the second offence was for failing to use a gear that was low enough to enable the vehicle to be driven safely when descending the down track of the South Eastern Freeway. Simultaneously, vehicles registered with a gross vehicle mass (GVM) between 4½ tonnes and six tonnes, or a GVM of less than 4,501 kilograms but more than 12 seats, were reclassified as a truck or bus and the 60 km/h or lower posted speed limit applied to these vehicles from the Crafers interchange to the bottom of the South Eastern Freeway. This reclassification caught many drivers unaware.

The associated penalties included a six-month licence disqualification, six demerit points and a \$1,036 expiation fee for individuals, with an additional \$25,000 body corporate levy for a business where the vehicle detected speeding was registered to a business that had failed to nominate the driver of the vehicle.

Measures in the Bill to lessen the penalties include removing the six-month licence disqualification applying for a first offence and reducing the disqualification periods applying to subsequent offences; and reducing the severity of fines imposed.

(16, 17 October, 4, 5 December 2020; Act 39 of 2019)

STATUTES AMENDMENT (SPIT HOODS)

The purpose of this Bill is to amend the *Correctional Services Act 1982*, the *Mental Health Act 2009*, the *Sheriff's Act 1978*, the *Summary Offences Act 1953* and the *Youth Justice Administration Act 2016* to prohibit the use of spit hoods.

(17 October, 27 November 2019; lapsed due to prorogation in House of Assembly)

SUMMARY OFFENCES (CUSTODY NOTIFICATION SERVICE) AMENDMENT

The purpose of the Bill is to amend the *Summary Offences Act 1953* by establishing a service which ensures that when Aboriginal people are taken into custody the Aboriginal Legal Rights Movement is notified.

(7 November 2018; lapsed due to prorogation)

SUPPORTED RESIDENTIAL FACILITIES (AGED CARE FACILITIES) AMENDMENT

The purpose of the Bill is to amend the *Supported Residential Facilities Act 1992* to make it a condition of a supported residential facilities licence that audio-visual recording equipment is installed in the bedroom of each resident and in all common areas and that the equipment is operating at all times.

(14 November 2018; lapsed due to prorogation)

VALUATION OF LAND (SEPARATE VALUATIONS) AMENDMENT

The purpose of the Bill is to amend the *Valuation of Land Act 1971* to clarify that separate assessments should only be made in circumstances where it is required by law, or the land has been separately occupied since 1967, or under a shack site lease and is situated where formal subdivision is prohibited. The Bill also stipulates that the Valuer-General must change the valuation roll if they are aware that a valuation is inconsistent with valuations of other relative properties on the roll.

(17 October 2018; lapsed due to prorogation)

WORK HEALTH AND SAFETY (INDUSTRIAL MANSLAUGHTER) AMENDMENT

This Bill seeks to introduce the offence industrial manslaughter into the *Work Health and Safety Act 2012*. This offence covers a situation where an individual or corporation's conduct causes the death of a worker or where that individual or corporation's recklessness or negligence caused serious harm or death to that worker. An employer is guilty of an offence if:

- the employer breaches their duty of care;
- the employer knew or was recklessly indifferent that the act or omission constituting the breach would create a substantial risk of serious harm to a person; and
- the breach causes the death of a person.

(1 May 2019; lapsed due to prorogation)

WORK HEALTH AND SAFETY (SCISSOR LIFT CONTROL) AMENDMENT

The purpose of this Bill is to amend the *Work Health and Safety Act 2012* to ensure that a scissor lift is only operated when a safety observer or a spotter is present to enable that person to respond in an emergency, and that each scissor lift in use at a workplace is of the same make and model and has the same operating controls.

(3 July 2019; lapsed due to prorogation)
