AGEING AND ADULT SAFEGUARDING (RESTRICTIVE PRACTICES) AMENDMENT

The purpose of this Bill is to amend the *Ageing and Adult Safeguarding Act 1995* to regulate restrictive practices used by prescribed aged-care service providers to aged persons in residential care or home care provided under the commonwealth Aged Care Act 1997 and establish an authorisation process for positive behaviour management plans ensuring transparency and accountability.

(2 December 2020 - lapsed due to dissolution)

CHILDREN AND YOUNG PEOPLE (SAFETY) (INQUIRY INTO FOSTER AND KINSHIP CARE) AMENDMENT

The Bill seeks to establish an independent inquiry into foster and kinship care in the State to review the adequacy of:

- existing complaints mechanisms within the Department for Child Protection (the Department);
- existing consultation processes between the Department, other persons and bodies and foster and kinship carers;
- documentation and information held by the Department, other persons and bodies and its availability to foster and kinship carers; and
- internal processes and arrangements within the Department and other persons and bodies to examine that there is a sound partnership with foster and kinship carers.

Overall the inquiry aims to ensure that the rights of children in foster and kinship care are realised, respected and addressed. The inquiry will make such recommendations for change affecting foster and kinship carers as it considers necessary.

The Bill stipulates that the inquiry must finish within six months of its establishment and the report will be presented to the Minister, who must cause a copy of the report to be laid before both Houses of Parliament.

(17 November 2021 - Act No. 55 of 2021)

CIVIL LIABILITY (BYO CONTAINERS) AMENDMENT

The purpose of this Bill is to amend the *Civil Liability Act 1936* so that a person who sells food or beverage to a customer in the customer's own container incurs no civil liability for loss of life or personal injury arising from consumption of the food or beverage so sold.

(22 September, 13 October 2021 - lapsed due to dissolution in House of Assembly)

CIVIL LIABILITY (INSTITUTIONAL CHILD ABUSE LIABILITY) AMENDMENT

This Bill introduces four important reforms for institutional child abuse victims/survivors. The Bill will:

- reverse the onus of proof in negligence cases;
- codify and expand the definition of vicarious liability;
- assist in identifying a proper defendant; and
- enable the setting aside of previous settlements.

These reforms are based on, and consequential to, recommendations from the Royal Commission into Institutional Responses to Child Sexual Abuse and have been developed through broad consultation with stakeholders, including government agencies; courts and other legal organisations; children's advocates; community service providers; religious organisations; and peak bodies for schools, childcare centres and foster care agencies.

The scope of the Bill extends beyond sexual abuse to include serious physical abuse and related psychological abuse committed in an institutional context.

Under this legislation those victims who reached unfair settlements on the understanding that they had no legal right to sue may wish to seek to have those agreements set aside.

(17 November 2021 - Act No. 55 of 2021)

CONSTITUTION (PLEDGE OF LOYALTY) AMENDMENT

The purpose of this Bill is to amend the amend the *Constitution Act 1934*, and to make a related amendment to the *Oaths Act 1936* to remove the oath to the Sovereign and replace with a pledge of loyalty to Australia and to the people of South Australia

(1 July 2020 - lapsed due to dissolution)

CONTROLLED SUBSTANCES (CONFIDENTIALITY AND OTHER MATTERS) AMENDMENT

This Bill facilitates the implementation of a Real-Time Prescription Monitoring system in South Australia to provide a national source of information about the prescribing and dispensing of high-risk medicines in real-time to address the growing problem of addiction, overdose and death associated with legal use of these medicines.

The Real-Time Prescription Monitoring software will integrate with existing prescriber and pharmacist software to provide access to real-time prescribing and dispensing information and to enable real-time detection and alerts for regulators and prescribers. The built-in alert functionality will help health practitioners identify patients with a history of problematic access to high-risk prescription medicines and enable them to make more informed clinical decisions that minimise the risk of overdose, addiction and death.

The amendments to the *Controlled Substances Act 1984* are limited to those required to effectively implement Real-Time Prescription Monitoring, and these amendments will not change the broader intent or objectives of the Act, or the role of the government regulator. The proposed changes include:

- Sanctions for inappropriate use of data collected under the Real-Time Prescription system;
- Additional regulation making powers so that the current general confidentiality provisions can be clarified and tightened under the Controlled Substance (Poisons) Regulations 2011;
- Increasing penalties for offences under the Controlled Substances (Poisons) Regulations 2011, along with the ability to expiate offences;
- Allowing information under section 18A to be provided electronically including via the new system.

The changes to the confidentiality provisions will ensure that only relevant patient information is collected, can only be accessed by relevant health professionals and regulators, and is only used for the explicit purpose of the system, which is to minimise the risk of harm from the legitimate use of high-risk prescription medicines.

(17 June; 21, 22 July 2020 - Act No. 28 of 2020)

COORONG ENVIRONMENTAL TRUST

This Bill establishes the Coorong Environmental Trust, with the aim of providing solutions to problems in the Coorong and Lower Lakes relating to the restoration of flows, ecological stability and long-term sustainability.

The Bill advocates for an independent board consisting of members who represent organisations with a professional, financial, physical or legal commitment to the ecological wellbeing of the Coorong.

The Trust will be independent from government to encourage and empower local and scientific communities to provide optimal management of the Lower Lakes and Coorong. The government will, however, be provided with reports and other information gathered by the Trust to inform ongoing decision-making.

The role of the Trust will include:

- creating and maintaining a repository for environmental data and research;
- preparing an annual State of our Estuary report;
- preparing, adopting and maintaining a set of rules relating to the membership, management and operation of the trust;

- providing independent, impartial scientific advice on the state of the Coorong to stakeholders;
- providing guidance for future environmental research;
- monitoring and documenting environmental flow outcomes;
- coordinating and implementing a comprehensive water quality monitoring program;
- independently assessing proposed solutions to ecological challenges;
- establishing a fundraising committee and a wetland science committee to enable the trust to carry out its functions with financial independence; and
- performing and carrying out other functions assigned by regulators.

(27 October, 17 November, 1 December 2021 - Act No. 58 of 2021)

CORONERS (MISCELLANEOUS) AMENDMENT

The purpose of this Bill is to amend the *Coroners Act 2003* to clarify the jurisdiction of the Coroner's Court to identify those involved in an event being investigated where it appears they may have caused or contributed to a death, or require those persons, agencies or organisations to provide information so that the Coroner can assess the accountability or responsibility of the party involved in the event.

The Bill also gives the nominated representative of the family of a person to whom proceedings to which this section applies is entitled to appear in those proceedings allow them to examine and cross-examine any witness testifying in the proceedings.

(29 April 2020 - lapsed due to dissolution)

COVID-19 EMERGENCY RESPONSE (FURTHER MEASURES) (NO 2) AMENDMENT

This Bill aims to bolster the legislative framework underpinning South Australia's COVID-19 response by strengthening the protection of front-line workers in pharmacies and general practices.

The provisions of the Bill will only operate during the declared COVID-19 emergency period and will expire in the same way as other provisions of the *COVID-19 Emergency Response Act 2020*, that being either when the emergency is no longer declared or six months after the commencement of the Act, being 9 October 2020.

Firstly, the Bill includes pharmacists, pharmacy assistants and persons performing duties in a pharmacy, as well as medical practitioners, nurses or persons otherwise performing duties at a place where medical treatment is provided within the scope of a prescribed emergency worker under the *Criminal Law Consolidation Act 1935*. This will provide such workers with the same additional protection as other front-line health workers, ensuring that anyone who assaults or causes harm to these front-line workers is subject to the same increased penalties.

Secondly, the Bill amends the *Health Practitioner Regulation National Law (South Australia) Act 2010* to provide the Pharmacy Regulation Authority South Australia with the power to authorise certain pharmacy premises to operate without a pharmacist physically in attendance, provided they are in attendance through the use of computer, video or audio links. This will allow the pharmacist to communicate with patients and appropriately trained pharmacy staff remotely.

COVID-19 pandemic preparedness and continuity planning for community pharmacies has highlighted the risk to continuity of services should there be an outbreak of COVID-19 in rural and remote areas of the state. The Bill seeks to support continuity of service through this emergency period.

(21, 22 July 2020 - Act No. 23 of 2020)

CRIMINAL LAW CONSOLIDATION (DOMESTIC ABUSE) AMENDMENT

The purpose of this Bill is to amend the *Criminal Law Consolidation Act 1935* to create a new offence against controlling or coercive behaviour in a relationship.

(20 February 2020 - lapsed due to dissolution)

CRIMINAL LAW CONSOLIDATION (HUMAN REMAINS) AMENDMENT

This Bill amends the *Criminal Law Consolidation Act 1935* to create new offences relating to the destruction, concealment or alteration of human remains for the purposes of concealing an offence or to influence legal proceedings and the defiling of human remains, regardless of the purpose.

(22 September 2021, 10 February 2022 - lapsed due to dissolution in House of Assembly)

CRIMINAL LAW CONSOLIDATION (STEALTHING) AMENDMENT

The purpose of this Bill is to amend the *Criminal Law Consolidation Act 1935* to amend Division 11 Section 46 of the Act to expand the list of factors which can negate consent to include non-consensual condom removal.

(13 October 2021 - lapsed due to dissolution)

DANGEROUS SUBSTANCES (LPG CYLINDER LABELLING) AMENDMENT

This Bill has its genesis in the tragic death of Port Lincoln teenager Patrick Ryan. Patrick died on 9 February 2020 while attending a party and inhaling liquefied petroleum gas (LPG) from a barbecue gas cylinder. His death highlighted that inhaling LPG, known as 'huffing', is a widespread phenomenon. Statistics show that the mortality rate from this practice is high, with death being caused by heart failure and often occurring within minutes of inhalation. If not fatal the practice can also cause permanent damage to the brain and other organs. The intention of this Bill is to prevent similar deaths or injuries by requiring a person selling or supplying LPG in South Australia to ensure the cylinder in which the gas is sold or supplied, or to which it is transferred at the point of sale or supply, is labelled with a warning stating that the gas is LPG and that LPG may cause injury or death if inhaled. Sellers or suppliers of gas will be required to affix such a label to all LPG cylinders they sell or fill.

(17 June, 2 July 2020 - Act No. 22 of 2021)

DISABILITY INCLUSION (COMMUNITY VISITOR SCHEME) AMENDMENT

The purpose of this Bill is to amend the *Disability Inclusion Act 2018* to allow community visitors to enter private homes and access environments in which NDIS participants receive support and services.

(3 June, 22 July 2020 - Bill negatived in House of Assembly at second reading)

DISABILITY INCLUSION (RESTRICTIVE PRACTICES—NDIS) AMENDMENT

This Bill aims to protect and improve the rights of South Australians with disability under the National Disability Insurance Scheme (NDIS) who may be subject to the use of restrictive practices. It creates a new regime for the authorisation of the use of restrictive practices under the NDIS and supplements the existing legislative framework for NDIS participants. It will also enable South Australia to meet the national principles: a streamlined authorisation process covering all NDIS participants, enshrined in legislation.

In South Australia restrictive practices have erstwhile been regulated by a range of legislation including the *Mental Health Act 2009*, the *South Australian Civil and Administrative Tribunal Act 2013*, the *Advance Care Directives Act 2013*, the *Consent to Medical Treatment and Palliative Care Act 1995* and the *Guardianship and Administration Act 1993*. The Bill aims to establish a simplified framework and to provide safeguards against unlawful use of restrictive practices.

Under the existing legislative framework, South Australia uses a guardianship model to regulate restrictive practices, which gives a guardian the power to consent to restrictive practices. The introduction of the NDIS has resulted in an increase in the number of applications for guardianship orders. This will be avoided by implementing the authorisation regime for restrictive practices provided for in this Bill.

The new authorisation process also provides strong safeguards to people with disability, ensuring that any restrictive intervention can only be used:

- as a last resort;
- when there is a risk of harm to the person or others;
- if the use is the least restrictive way of ensuring the safety of the person or others;
- when the use is in accordance with an NDIS behaviour support plan; and
- when its use is not prohibited.

(4, 18 March, 1 April, 4, 6 May 2021 - Act No. 18 of 2021)

EDUCATION AND CHILDREN'S SERVICES (MOBILE PHONES IN SCHOOLS) AMENDMENT

The purpose of this Bill is to amend the *Education and Children's Services Act 2019* to enable the Minister to establish a trial of the use of secure mobile phone storage devices in not less than 20 Government secondary schools throughout the State; and that the trial must run for at least 12 months in each school.

(12 May 2021 - lapsed due to dissolution)

EMERGENCY MANAGEMENT (INFORMATION SECURITY) AMENDMENT

The purpose of this Bill is to amend the *Emergency Management Act 2004* to make it an offence to collect, use or disclose COVID-19 contact tracing data without authorisation and ensure the data is destroyed within a prescribed period.

(3 February 2020 - lapsed due to dissolution)

ENVIRONMENT PROTECTION (DISPOSAL OF PFAS CONTAMINATED SUBSTANCES) AMENDMENT

The purpose of this Bill is to amend the *Environment Protection Act 1993* to add a restriction on authorisation for disposal of PFAS contaminated substances.

(2 December 2020, 3 March 2021 - Bill withdrawn in the House of Assembly)

EQUAL OPPORTUNITY (UNLAWFUL ACTS AT WORKPLACE) AMENDMENT

The purpose of this Bill is to amend the *Equal Opportunity Act 1984* to ensure that the person with management and control of a workplace must take reasonable steps to prevent, as far as possible, prescribed unlawful acts at the workplace which includes discrimination, sexual harassment and victimisation.

(12 May, 27 October 2021 - lapsed due to dissolution)

FIRE AND EMERGENCY SERVICES (BUSHFIRES) AMENDMENT

The purpose of this Bill is to amend the *Fire and Emergency Services Act 2005* and to make related amendments to the *Emergency Management Act 2004* to establish a state-wide plan for conducting prescribed burns in the State Bushfire Management Plan and to add bushfire monitoring and detection cameras to the strategies contained in, and part of, the State Bushfire Management Plan.

(8 September, 13, 27 October 2021 - lapsed due to dissolution in House of Assembly)

FREEDOM OF INFORMATION (MINISTERIAL DIARIES) AMENDMENT

The purpose of this Bill is to amend the *Freedom of Information Act 1991* to require Ministers to make publicly available all meetings, events and functions which relate to their professional responsibilities on a monthly basis, not including personal meetings or information deemed to be contrary to the public interest.

(17 November, 1 December 2021 - lapsed due to dissolution)

FUEL WATCH

The purpose of this Bill is to facilitate the provision of information to consumers regarding the price and availability of fuel for retail sale and wholesale, to regulate the retail sale and wholesale of fuel, and for other purposes.

(17 June, 1 July 2020 - lapsed due to dissolution in House of Assembly)

GENDER EQUALITY

This Bill seeks to establish the office of the Commissioner for Gender Equality, to require certain entities to promote gender equality in the development of programs and delivery of services, to provide that certain entities prepare and implement an action plan to achieve gender equality in the workplace, to make a related amendment to the *Fair Work Act 1994* and for other purposes.

(12, 26 May, 17 November 2021 - lapsed due to dissolution in House of Assembly)

GENETICALLY MODIFIED CROPS MANAGEMENT (MISCELLANEOUS) AMENDMENT

This Bill seeks to repeal the *Genetically Modified Crops Management Regulations (Postponement of Expiry) Act 2017* and to revoke the Genetically Modified Crops Management Regulations 2008 to lift the moratorium on GM crops on mainland South Australia, and to legislate the moratorium on GM crops on Kangaroo Island.

(20 February, 29 April 2020 - Bill negated at second reading)

HEALTH CARE (GOVERNANCE) AMENDMENT

Parliament passed the first tranche of amendments to the *Health Care Act 2008* in July 2018, decentralising the public health system and enabling the establishment of the Local Health Network governing boards.

The governing boards have been operating since 1 July 2019, providing governance and oversight for health service delivery within each local area. Concurrently six new Local Health Networks in country South Australia have been operating, replacing the Country Health SA Local Health Network.

This Bill supports the newly decentralised system and its governing boards by establishing a new governance and accountability framework for the public health system, providing the following amendments:

- revising the functions of the Chief Executive of the Department for Health and Wellbeing;
- including provisions for service agreements between the Chief Executive and the Local Health Networks and SA Ambulance Service respectively;

- dissolving the Health Performance Council; and
- making minor amendments to sections of the Act reflecting the new governance and accountability framework for the public health system, or further clarifying their intent.

The Bill reflects a significant shift in the way that the Department and the Local Health Networks are operating and the changed role of the Chief Executive of the Department for Health and Wellbeing from having direct responsibility for the administration of the local health networks to a 'system leadership' role.

(17 June, 10 September, 15 October, 1, 3 December 2020, 8 June 2021 - Act No. 21 of 2021)

HEALTH PRACTITIONER REGULATION NATIONAL LAW (SOUTH AUSTRALIA) (TELEPHARMACY) AMENDMENT

The purpose of this Bill is to entrench the legal provisions authorising telepharmacy in South Australia. Similar temporary provisions had been supported as part of the various COVID-19 Emergency Response Acts over the 18 months prior to the Bill's introduction.

Telepharmacy is the provision of pharmaceutical care and products to a patient through the use of video and audio telecommunication where the pharmacist is not physically present in a pharmacy. This includes the provision of medicines where the pharmacist is not able to receive and/or provide the medicine to the patient personally.

Telepharmacy first was provided in South Australia in 2004 as part of a national trial to enable provision of care to rural and remote communities. More recently telepharmacy has been provided on an understanding that it is not prohibited under the *Health Practitioner Regulation National Law (South Australia) Act 2010*. This Bill will consolidate the legislative base and provide the Pharmacy Regulation Authority of South Australia with clear and express powers to authorise telepharmacy arrangements.

Further, the Commonwealth Government has moved to enable provision of medication review services through telehealth systems during the COVID-19 pandemic to ensure vulnerable patients can receive pharmacist-delivered support while remaining isolated from COVID-19. This enhances the safety of both patients and pharmacists and ensures continuity of care.

This Bill assists in the provision of safe and quality healthcare for the community through access to pharmacy services which would otherwise be unavailable.

(15 October, 3 December 2020, 26 August 2021 - Act No. 41 of 2021)

HERITAGE PLACES (ADELAIDE PARK LANDS) AMENDMENT

The purpose of this Bill is to amend the *Heritage Places Act 1993* and to make a related amendment to the *Planning, Development and Infrastructure Act 2016* to include the Adelaide Park lands on the state's heritage list.

(1 December 2021, 8 February 2022 - lapsed due to dissolution)

HOLIDAYS (CHRISTMAS DAY) AMENDMENT

The purpose of this Bill is to amend the *Holiday Act 1910* to ensure that 25 December will be a public holiday and bank holiday but when that day falls on a Saturday or Sunday, that day and the following Monday will be public holidays and bank holidays.

(27 October, 17, 30 November 2021 - no agreement reached at Conference - Bill laid aside in House of Assembly)

INDEPENDENT COMMISSIONER AGAINST CORRUPTION (CPIPC RECOMMENDATIONS) AMENDMENT

The Bill has its origins in a report of the Parliament's Crime and Public Integrity Policy Committee (CPIPC), tabled in December 2020. A number of recommendations from that report have been incorporated as provisions into this amending Bill, including the following:

- that the Commissioner is to be responsible for corruption and to establish a commission
- that the Office for Public Integrity is to be established as a separate entity
- the repeal of the classification of misconduct and maladministration as serious or systemic
- amending confidentiality provisions
- to rename the ICAC Reviewer as the Inspector of ICAC and confer further functions upon that role
- to confer further functions upon the CPIPC
- to provide that members of the public can attend Office for Public Integrity agencies in person

The Bill proposes to separate corruption from maladministration and misconduct matters in regard to which body investigates which element.

Under the Bill, the Independent Commission Against Corruption will be the inquiry agency with the responsibility for corruption, as the name says. The Ombudsman will be the inquiry agency in most circumstances for misconduct and maladministration matters.

The Bill also proposes changes to both the front end and back end of the complaints investigation system. At the front end the Office of Public Integrity (which receives, assesses and refers complaints about corruption, misconduct and maladministration) will be made newly independent. The new back end of the system will have the new Inspector to replace the current Reviewer. The Inspector will provide oversight of both the ICAC and the Ombudsman, and will be given expanded powers.

This reflects stronger oversight bodies that are in place in other Australian jurisdictions.

These new powers will include the ability to recommend compensation where a person has suffered undue reputational damage as a result of inquiries.

(25 August, 22, 23 September 2021 - Act No. 38 of 2021)

INQUIRY INTO PALLIATIVE CARE

The purpose of this Bill is to direct the South Australian Health Performance Council to undertake an inquiry into the South Australian palliative care system and to make recommendations on how it can be improved to ensure that all South Australians have equitable access to palliative care.

(13, 27 October, 17 November 2021 - lapsed due to dissolution in House of Assembly)

LABOUR HIRE LICENSING (MISCELLANEOUS) AMENDMENT

The Labour Hire Licensing (Miscellaneous) Amendment Bill amends the *Labour Hire Licensing Act 2017* with a view to improve and clarify the scope and application of the Act.

Following a review of the scheme it was determined that it applied to a range of businesses that were not intended to be captured, as opposed to focusing on the exploitation of workers in high-risk industries.

These laws were deemed to create an unnecessary layer of red tape for a number of industries. Some examples of businesses that are currently captured, but will not be under this Bill, include:

- IT consultants being outsourced to various businesses;
- dental labour hire businesses providing hygienists, dentists and receptionists;
- legal firms engaging in labour hire by providing legal practitioners to work within other businesses as in-house counsel or barristers being sent to work for various clients;
- universities sending academic staff to other education institutions, as well as medical professions being sent to act as lecturers at universities; and
- church ministers being sent to other parishes where the resident minister is unavailable.

The Bill seeks to narrow the scope of the scheme to ensure that the laws apply specifically to labour hire providers operating within industries where workers are more vulnerable to exploitation.

(20 February, 24 March, 16 June 2020 - Act No. 18 of 2020)

LAND TAX (DISCRETIONARY TRUSTS) AMENDMENT

The two amendments contained in this Bill seek to address some issues caused by delays in taxpayers receiving their 2020-21 land tax assessments by amending the *Land Tax Act 1936* and the *Valuation of Land Act 1971*.

The land tax reform package which passed Parliament in 2019 made significant changes to the collection of land tax in South Australia commencing at the 2020-21 financial year. Due to the complexity of the new system and some complex land holding ownership structures needing to be reviewed, there are still a number of taxpayers yet to be billed.

The first amendment amends the *Land Tax Act 1936* to extend the deadline for nominating a designated beneficiary for pre-existing trust land to 31 December 2021 (being a further six months from the current 30 June 2021) and allow for the giving of a notice of a designated beneficiary to take effect for the financial year prior to the one in which the notice is lodged.

The second amendment amends the *Valuation of Land Act 1971* to extend the time in which an objection to the 2020-21 land site value can occur, by allowing an objection to the 2020-21 site value to occur within 60 days after the service of the 2020-21 land tax assessment, even if that assessment is issued in the 2021-22 financial year and the site values it relates to are no longer in force.

These measures will ensure that trustees of discretionary trusts are able to receive their 2020-21 land tax assessments before deciding whether to nominate a designated beneficiary. The measures also preserve landowners' objection rights on the site value of a property, and ensure that they are not disadvantaged by any delay in receiving their 2020-21 land tax assessments.

(13, 27 May, 9 June 2021 - Act No. 23 of 2021)

LEGISLATION INTERPRETATION

This Bill will repeal and replace the *Acts Interpretation Act 1915*.

The Acts Interpretation Act has set out the rules for interpreting Acts of Parliament and legislative instruments, as well as the rules around the operation and effect of legislation and legislative instruments. It contains a dictionary that applies to the entire statute book and rules about services and penalties that also apply across all legislation.

The Act has been amended many times in a piecemeal way over the last century. This Bill identifies and addresses anomalies, provisions that require updating, and where possible aims for harmonisation with the interpretation acts of other jurisdictions.

The Bill improves the order and layout of the provisions to make them easier to find and use, moves some provisions to other more appropriate legislation and adds new provisions to reflect developments in statutory law and changes in society. It also employs a consistency in language.

Some changes contained in the Bill which modernise or reflect societal changes include:

- a new provision that will allow certain meetings to be held remotely
- amending the definition of 'Gazette' in a way that recognises electronic publication of the Government Gazette
- updating the schedule of divisional penalties to reflect the current scale that is used for penalties that have a monetary value
- updating the provisions relating to the calculation of time periods in order to simplify and improve useability

(6, 25, 27 May, 10, 24 June, 23 September 2021 - Act No. 36 of 2021)

LOCAL GOVERNMENT (FIXED CHARGES) AMENDMENT

The purpose of this Bill is to amend the *Local Government Act 1999* to not allow councils to be able to charge a minimum rate for an individual living unit in a retirement village.

(20 February 2020 - lapsed due to dissolution)

MEMBERS OF PARLIAMENT (REGISTER OF INTEREST) (ADDITIONAL DISCLOSURE) AMENDMENT

The purpose of this Bill is to amend the *Members of Parliament (Register of Interests) Act 1983* to include additional interests in the register.

(3 March 2021 - lapsed due to dissolution)

MINING (ENVIRONMENTAL IMPACT OF PRIVATE MINES) AMENDMENT

The purpose of this Bill is to amend the *Mining Act 1971* to impose a similar regulation for private mines to other mines by removing the limited definition of 'environment' that exists specifically for private mines within that Act and adding the broader definition that exists for other mining operations in South Australia

(23 June, 13 October 2021 - Bill negated at second reading)

MUTUAL RECOGNITION (SOUTH AUSTRALIA) (FURTHER ADOPTION) AMENDMENT

This Bill provides the legislative amendments required to support a uniform national scheme for the automatic mutual recognition of occupational licences within Australia. It is consistent with the Government's obligations under the Intergovernmental Agreement on Automatic Mutual Recognition of Occupational Registration.

The Commonwealth Government, in collaboration with state and territory governments, developed the uniform automatic mutual recognition scheme through consultation and engagement with industry, trade unions and regulators.

In June 2021, the Commonwealth Parliament passed amendments to the *Mutual Recognition Amendment Act 1992* (C'th) introducing a uniform scheme of automatic mutual recognition to enable an individual registered for an occupation in their home state to be taken to be registered to carry on, in a second state, the activities covered by their home state registration.

Automatic mutual recognition aims to increase the strength and resilience of the economy by reducing the time and cost for Australians to take up jobs wherever they arise within the nation.

(26 August, 12 October 2021 - Act No. 54 of 2021)

NATIONAL PARKS AND WILDLIFE (BAN ON HUNTING PROTECTED ANIMALS) AMENDMENT

The purpose of this Bill is to amend the *National Parks and Wildlife Act 1972* to ban the hunting of protected animals in South Australia and the declaration of an open season.

(17 March 2021 - lapsed due to dissolution)

NATIONAL PARKS AND WILDLIFE (WOMBAT BURROWS) AMENDMENT

The purpose of this Bill is to amend the *National Parks and Wildlife Act 1972* to prohibit the destroying, damaging or disturbing a wombat burrow.

(1 December 2021 - lapsed due to dissolution)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (ADELAIDE PARK LANDS) AMENDMENT

The purpose of the Bill is to amend the *Planning, Development and Infrastructure Act 2016*, to ensure that any amendment to the Planning and Design Code that relates to development in the Adelaide Parklands must be approved by resolution of both houses of parliament.

(27 October, 17 November 2021 - Bill negated at second reading)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (COMMENCEMENT OF CODE) AMENDMENT

The Planning and Design Code referred to in the title of this Bill is a codification of the 72 different local government development plans currently in use. It has been established under the *Planning, Development and Infrastructure Act 2016* and has a scheduled three phase commencement, with the final phase to commence on 1 July 2020.

The Code aims to provide a simplified framework in relation to all development in South Australia and is to be administered using a new electronic e-planning system which will alter the way planning rules are stored, retrieved and maintained.

However, some inconsistencies have been identified in the draft Code, some policy is yet to be finalised and various community sectors have requested more time to become acquainted with the Code and its e-planning system before its final implementation.

In order to address these issues this Bill provides the Minister for Planning with the discretion to delay the complete implementation of the Planning and Design Code beyond 1 July 2020, to a date to be fixed by proclamation.

(5 March 2020 - Act No. 5 of 2020)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (GAS INFRASTRUCTURE) AMENDMENT

The purpose of the Bill is to amend the *Planning, Development and Infrastructure Act 2016*, to make the requirement to connect to gas infrastructure void.

(9 June, 1 December 2021 - lapsed due to dissolution in House of Assembly)

PLANNING, DEVELOPMENT AND INFRASTRUCTURE (REGULATED TREES) AMENDMENT

The purpose of this Bill is to amend the *Planning Development and Infrastructure Act 2016* and to make a related amendment to the *Development Act 1993*, to ensure that a significant or regulated tree removal application cannot be granted unless the replacement use or replacement buildings have also been approved.

(23 September 2020 - lapsed due to dissolution)

PUBLIC SECTOR (ANNUAL PUBLIC MEETING) AMENDMENT

The purpose of this Bill is to amend the *Public Sector Act 2009* to ensure that public sector agencies hold an annual public meeting.

(9 September 2020 - lapsed due to dissolution)

REFERENDUM (RETAIL TRADING)

The purpose of this Bill is to ensure that The Retail Trading Bill 2021 must, if passed by the Parliament but before being presented to the Governor for assent, be submitted to a referendum of electors for the House of Assembly. The day appointed for the referendum must be a day that has been fixed for a general election of members of the House of Assembly. If a majority of electors voting at the referendum approve the Retail Trading Bill 2021 then the Bill will be presented to the Governor for assent.

(13 May, 8, 26 June - Bill negated at second reading)

RESIDENTIAL TENANCIES (MISCELLANEOUS) AMENDMENT

The purpose of this Bill is to amend the *Residential Tenancies Act 1995* relating to disclosures, misleading or deceptive conduct, fixed price rent, termination of agreements and the creation of a non-compliance register.

(9 September 2020 - lapsed due to dissolution)

RESIDENTIAL TENANCIES (RENTING WITH PETS) AMENDMENT

The purpose of this Bill is to amend the *Residential Tenancies Act 1995* to ensure that if the landlord does not consent to the tenant's application for a pet or pets, the tenant can apply to SACAT and SACAT will make the decision, having considered the circumstances in each case.

(23 September, 3 December 2020, 30 March 2021 - Bill negated at 3rd reading)

RETAIL TRADING

The purpose of this Bill is to provide for the closing of retail shops in the metropolitan area of Adelaide on certain days and to repeal the *Shop Trading Hours Act 1977*.

(13 May, 8, 26 June 2021 - Bill negated at second reading)

RETURN TO WORK (COVID-19) AMENDMENT

The purpose of this Bill is to amend the *Return to Work Act 2014* to ensure that a worker who, in the course of employment in listed industries or services, and has face to face contact with members of the public, will be taken to have been diagnosed with COVID-19 at the time of the test and to be suffering from a notional work injury.

(8 April, 13 May 2020 - lapsed due to dissolution)

RETURN TO WORK (COVID-19 INJURY) AMENDMENT

The purpose of this Bill is to amend the *Return to Work Act 2014* to ensure that a worker who, in the course of employment in listed industries or services, will be taken to have been diagnosed with COVID-19 at the time of the test and to be suffering from a notional work injury.

(13 May, 3 June 2020 - lapsed due to dissolution in House of Assembly)

RETURN TO WORK (IMPAIRMENT ASSESSMENT GUIDELINES) AMENDMENT

The purpose of this Bill is to amend the *Return to Work Act 2014* to enable the Governor, by regulation made on recommendation of the Minister, to establish guidelines for the purposes of the assessment of permanent impairment.

(25 August, 8 September 2021 - lapsed due to dissolution in House of Assembly)

RETURN TO WORK (POST TRAUMATIC STRESS DISORDER) AMENDMENT

The purpose of this Bill is to amend the *Return to Work Act 2014* so that if a worker who has been employed as a first responder is diagnosed with post-traumatic stress disorder, the disorder is presumed, in the absence of proof to the contrary, to have arisen from employment.

(20 February 2020 - lapsed due to dissolution)

ROAD TRAFFIC (DRUG SCREENING) AMENDMENT

The purpose of this Bill is to amend the *Road Traffic Act 1961* to enable the Police to impose immediate licence disqualifications or suspensions for drug driving.

(9 September 2020 - lapsed due to dissolution)

ROAD TRAFFIC (MEDICINAL CANNABIS) AMENDMENT

The purpose of this Bill is to amend the *Road Traffic Act 1961* to ensure that a person whose blood or oral fluid contains delta-9-tetrahydrocannabinol from a legal cannabis product, which is a prescription drug, and for which the person has a prescription or other authority to obtain, possess and use, and which has been used in accordance with that prescription or authority, is not guilty of an offence.

(3 February 2021 - lapsed due to dissolution)

ROAD TRAFFIC (SOUTH EASTERN FREEWAY OFFENCES) AMENDMENT

The purpose of this Bill is to amend the *Road Traffic Act 1961* by removing all buses from the restrictions imposed on heavy vehicle. Further the Bill restores judicial discretion in regard to matters where the driver or owner elects to be prosecuted.

(4 March, 22 July 2020 - lapsed due to dissolution in House of Assembly)

SENTENCING (HATE CRIMES) AMENDMENT

This Bill amends section 11 of the *Sentencing Act 2017*, adding that a court must take into account if an offence was wholly or partly motivated by hatred for, or prejudice against, a group of people (including people of a particular race, religion, sex, sexual orientation, gender identity or age, or people having an intersex variation or living with a particular disability) with the defendant knowing, or believing, that the victim was a member of that group or groups - whether or not there were also other reasons for the commission of the offence.

Whilst hate or prejudice may currently be taken into account at sentencing for criminal offences under the Act, it is the intent of this Bill that making it a mandatory and explicit consideration would ensure greater consistency in sentencing and better consideration of the offence in a wider context.

(2 December 2020, 25 August 2021 - Act No. 46 of 2021)

SOCIAL WORKERS REGISTRATION

The objects of this Bill are:

- to establish and maintain a registration system for social workers in South Australia;
- to safeguard the public interest by ensuring that only suitably trained and qualified persons are able to practise as social workers;
- to encourage the maintenance of high professional standards of both competence and conduct by registered social workers;
- to ensure that registered social workers are held professionally accountable for their conduct.

This Bill establishes the Social Workers Registration Board of South Australia. The role of the board is as follows:

- to administer the provisions of this legislation for the regulation of the practice of social work;
- to provide a definition of social work services;
- to establish and maintain the register;
- to prepare or endorse codes of conduct, professional standards and ethical guidelines for registered social workers;
- to determine the qualifications and other requirements appropriate for registration;
- to receive and determine applications for registration of social workers;
- to hear and make determinations in disciplinary proceedings against a person;
- to carry out other functions assigned to the Board under this legislation or by the Minister.

The Bill requires that all social workers must be registered and that someone cannot work as a social worker without being registered. The Bill includes transitional provisions for people who have been practising as social workers for some time but who cannot currently meet the qualification requirements.

(12 October, 27, 17 November, 1 December 2021 - Act No. 56 of 2021)

SOUTH AUSTRALIAN EMPLOYMENT TRIBUNAL (COSTS) AMENDMENT

The amendments contained in this Bill are aimed at removing any doubt that the South Australian Employment Tribunal (SAET) has the power to award costs to parties in criminal proceedings. The Bill would backdate this provision to 1 July 2017, which is when SAET was first conferred criminal jurisdiction over industrial offences that had previously been heard in the Magistrates Court. These are mainly offences under the *Work Health and Safety Act 2012* and the *Return to Work Act 2014*.

Costs have been routinely awarded by SAET in the exercise of its criminal jurisdiction. This is consistent with the longstanding practice in South Australia that costs apply in criminal prosecutions in the Magistrates Court, but is arguably contrary to section 52 of the Act, which provides that 'subject to this Act or a relevant Act, parties bear their own costs in any proceedings before the Tribunal'.

It would appear that the lack of a clearly stated power in the SAET Act to award costs in criminal proceedings was an oversight at the time of the drafting of the legislation conferring the industrial offences criminal jurisdiction on SAET.

(12 November, 1, 3 December 2020 - Act No. 2 of 2021)

SOUTH AUSTRALIAN PUBLIC HEALTH (CONTROLLED NOTIFIABLE CONDITIONS) AMENDMENT

This Bill seeks to amend the *South Australian Public Health Act 2011* to allow the Chief Public Health Officer additional powers to pre-emptively control the spread of notifiable conditions such as COVID-19.

The amendments will provide the Chief Public Health Officer with greater capacity to rapidly respond to and contain public health risks related to infectious diseases while maintaining appropriate protections for individuals, such as case reviews and the capacity to appeal to the courts.

The amendments include:

- allowing a more timely and rapid process for the Chief Public Health Officer to detain a person engaging in conduct that presents a risk to the public;
- allowing detention, in urgent circumstances, where there have been no prior breaches or noncompliance, or the service of a direction;
- expanding the application of controls under the Act to people who could have been exposed to a controlled notifiable condition;
- where necessary, allowing verbal orders or directions to require testing, counselling or actions to prevent the spread of infection, or detention, to be followed with a written notice; and
- clarifying that an order to remain at a specified place could include a hospital or quarantine facility.

(3 March 2020 - Act No. 1 of 2020)

SOUTH AUSTRALIAN PUBLIC HEALTH (EARLY CHILDHOOD SERVICES AND IMMUNISATION) AMENDMENT

This Bill is the second phase of measures designed to strengthen immunisation requirements for children in early childhood services.

Recent data has shown that between five and twelve per cent of children in South Australia do not get timely or complete routine vaccinations scheduled for the early years of life.

In 2019, the first phase of amendments to the *South Australian Public Health Act 2011* were made to strengthen the ability of public health officials to respond to outbreaks of vaccine-preventable disease in early childhood service centres.

From the beginning of 2020 parents have been required to provide immunisation records to staff at early childhood service centres when they enrol a child and at other specified times. The service centres are required to keep the records and provide them to the Chief Public Health Officer on request. The Chief Public Health Officer can exclude susceptible children during an outbreak of a vaccine preventable disease.

This Bill increases protection measures by prohibiting or suspending the enrolment of children who are not up to date with vaccinations unless they meet certain specified exemption criteria.

(20 February, 5 March, 7 April 2020 - Act No. 12 of 2020)

SOUTHERN STATE SUPERANNUATION (CHOICE OF FUND) AMENDMENT

The purpose of this Bill is to amend the *Southern State Superannuation Act 2009* to allow a person who is a member of the Triple S scheme to elect to transfer their superannuation arrangements under this Act to a complying fund

(17 June, 9 September 2020 - lapsed due to dissolution)

SPENT CONVICTIONS (DECRIMINALISED OFFENCES) AMENDMENT

This Bill amends the *Spent Convictions Act 2009* to expand and improve the system for spending convictions for historical homosexual offences.

South Australia was the first jurisdiction to introduce a legislative system for removing historic homosexual convictions. The *Spent Convictions (Decriminalised Offences) Amendment Act 2013* introduced a new category of spendable offence called a designated sex-related offence (DSRO). A DSRO is an offence involving consensual sexual activity between adults or, in some cases, consensual activity between 16 and 17 year olds. However, a review of the legislation in 2019, revealed some deficiencies in the current regime. This Bill makes numerous changes to make the system fairer and more accessible.

The Bill removes the requirement for a person to complete a 10-year crime free period before they can have their historical homosexual offences spent.

The Bill moves applications to spend DSROs into their own section so that it is no longer dealt with in the same section as non-decriminalised sex offences.

The Bill expands the definition of DSRO, allowing more people to access the system for spending decriminalised sex offences.

The Bill also allows for spending homosexuality related offences other than sex offences. In the past, homosexual people would be charged with general offensive behaviour crimes for conduct such as showing affection with a person of the same sex in public or wearing clothing considered inappropriate for their sex.

The Bill will introduce a new section to allow persons to apply to have a conviction for a public decency and morality offence spent by order of a magistrate.

Finally, the Bill provides that specified next of kin or legal representatives may apply to spend the historical homosexual conviction of a deceased or incapacitated person.

(15 October, 10, 12 November 2020 - Act No. 42 of 2020)

STATE PROCUREMENT REPEAL

In late 2018, the South Australian Productivity Commission was tasked with undertaking an inquiry into public sector procurement. Key recommendations made by the Commission were to repeal the *State Procurement Act 2004*, abolish the State Procurement Board and replace the board's policies and guidelines.

In parallel, the Statutory Authorities Review Committee conducted an inquiry into the State Procurement Board and made similar recommendations.

This Bill has been introduced in order to implement these recommendations. It repeals the *State Procurement Act 2004* and the State Procurement Regulations 2005 and dissolves the State Procurement Board and its relevant policies and guidelines.

(2, 21 July 2020 - Act No. 31 of 2020)

STATUTES AMENDMENT (ABOLITION OF DEFENCE OF PROVOCATION AND RELATED MATTERS)

This Bill implements the preferred recommendations in stage 1 and stage 2 reports of the South Australian Law Reform Institute (SALRI), entitled 'The Provoking Operation of Provocation'. The SALRI reports recommended that the common law defence of provocation should be abolished. At common law, if successfully raised provocation operates as a partial defence, reducing murder to manslaughter. The defence has been criticised for being complex, gender-biased and encouraging victim blaming and is at odds with community expectations.

Sometimes referred to as the gay panic defence, it has been controversial in its use by accused persons who have perpetrated violence against members of the gay community. The defence has had some limited utility in the case of women who, having been the victims of prolonged family violence, finally retaliate against their abuser. Absent the defence, these women may be convicted of murder and face a mandatory sentence of life imprisonment, and a mandatory minimum non-parole period of 20 years.

In line with the recommendations in the SALRI reports, the Bill addresses this issue by ensuring that evidence of family violence and the circumstances surrounding it can be taken into account both at trial, particularly in the context of defences of self-defence and duress where the dynamics of a domestic relationship may be especially relevant and in sentencing, including in relation to murder.

The Bill seeks to strike a balance between ensuring the changes to the law operate fairly and practically, and that they do so without unintended consequences. To this end, the Bill contains amendments to the *Criminal Law Consolidation Act 1935*, the *Evidence Act 1929*, the *Sentencing Act 2017* and the *Bail Act 1985*.

(15 October, 10, 17 November 2020 - Act No. 43 of 2020)

STATUTES AMENDMENT (ANIMAL WELFARE REFORMS)

The purpose of this Bill is to amend the *Animal Welfare Act 1985* and the *Dog and Cat Management Act 1995* to improve the transparency and accountability when it comes to animal welfare.

(3 June, 22 July 2020 - Bill withdrawn and referred to Joint Committee)

STATUTES AMENDMENT (CHILD SEXUAL ABUSE)

This Bill introduces a number of outstanding reforms proposed by the Royal Commission into Institutional Responses to Child Sexual Abuse. The purpose of these reforms is to promote the identification of individuals who sexually abuse children and to ensure their appropriate conviction in the courts. It also seeks to protect and assist child sexual abuse victims through the court process to reduce the trauma that they often suffer. Some of the measures contained in the Bill are as follows:

Amendments to the *Criminal Law Consolidation Act 1935* provide for 'similar age' or 'reasonable belief' defence where a consenting victim is under 17 and create new offences of failing to report and failing to protect a child from sexual abuse.

Amendments to the *Criminal Procedure Act 1921* and the *Evidence Act 1929* contained in the Bill are aimed at alleviating the need for child sexual abuse victims and victims of domestic violence to attend court, where they might be again confronted by their abuser and often experience significant distress during cross-examination.

The Bill also inserts a new section into the Evidence Act to provide that the fact that information was gained during or in connection with a religious confession does not prevent or otherwise affect the giving of evidence. The Bill amends the *Sentencing Act 2017* in order to require the court, when setting a single sentence for an offence involving different victims or one committed on different occasions, to indicate the sentence that would have been imposed in respect of each offence and also to set sentences in accordance with the sentencing standards at the time of sentencing instead of the time of the offending.

The *Summary Offences Act 1953* is amended to require pre-recorded investigative interviews with police for all child sexual abuse victims, no matter what their age is at trial, instead of having to give evidence at trial.

The Bill also amends the *Young Offenders Act 1993* to reduce the necessity of having to give evidence at trial.

(24 August, 10 September 2021 - Act No. 57 of 2020)

STATUTES AMENDMENT (FREE MENSTRUAL HYGIENE PRODUCTS PILOT PROGRAM)

The purpose of this Bill is to amend the *Education Act 1972* and the *Education and Children's Services Act 2019* to enable the Minister to establish a program (the free menstrual hygiene products program) to trial the provision of free menstrual hygiene products to students in Government schools.

(7 April, 14 May 2020 - lapsed due to dissolution in House of Assembly)

STATUTES AMENDMENT (LIGHT POLLUTION AND NUISANCE)

The purpose of this Bill is to amend the *Environment Protection Act 1993* and the *Local Nuisance and Litter Control Act 2016* to include light as a pollutant or nuisance while removing certain forms of light.

(March 3, 2021)

STATUTES AMENDMENT (MANDATORY REPORTING)

The purpose of this Bill is to amend the *Children and Young People (Safety) Act 2017* and the *Criminal Law Consolidation Act 1935* to ensure that if a priest or other minister of religion forms a suspicion, in the course of carrying out their duties (including in the course of a confession made in accordance with the rules and usages of the relevant religion) that a person has committed a prescribed child sex offence, the priest or minister must notify a police officer of that suspicion as soon as practicable after forming the suspicion.

(May 13, 2020)

STATUTES AMENDMENT (REPEAL OF SEX WORK OFFENCES)

The purpose of this Bill is to amend the *Criminal Law Consolidation Act 1935* and the *Summary Offences Act 1953* to abolish offences relating to prostitution.

(April 8, 2020; June 18, 2020; February 3, 2021 Bill referred to a Select Committee)

STATUTES AMENDMENT (SPIT HOOD PROHIBITION)

This Bill inserts a prohibition on the use of spit hoods into five pieces of legislation: The *Correctional Services Act 1982*, the *Mental Health Act 2009*, the *Sherriff's Act 1978*, the *Summary Offences Act 1953* and the *Youth Justice Administration Act 2016*.

Earlier in 2021, the Department for Correctional Services determined to ban the use of spit hoods across all South Australian prisons. The decision was made following a comprehensive review of alternative protective measures for correctional services officers, where risk of contamination by means of bodily fluids is identified.

This Bill, however, puts the prohibition of spit hoods beyond doubt.

(17 June 2020, 23 September 2021 - Act No. 47 of 2021)

STATUTES AMENDMENT (UNIVERSITIES - CAPS ON VICE-CHANCELLOR SALARIES)

The purpose of this Bill is to amend the *Flinders University Act 1966*, the *University of Adelaide Act 1971* and the *University of South Australia Act 1990* to cap the salaries of vice-chancellors in South Australian universities.

(25 August 2021 - lapsed due to dissolution)

STATUTES AMENDMENT (USE OF FACIAL RECOGNITION SYSTEM)

The purpose of this Bill is to amend the *Casino Act 1997* and the *Gaming Machines Act 1992* to ensure that a licensee does not use information obtained by means of operating a facial recognition system except for a purpose of identifying a barred person within the meaning of Part 6 of the *Gambling Administration Act 2019*; or for the purposes of reducing the harm caused by gambling.

(2 December 2020, 22 September 2021 - lapsed due to dissolution in House of Assembly)

SUICIDE PREVENTION

The objects of the Bill are:

- to reduce the incidence of suicide in the State;
- to promote best practice suicide prevention policies;
- to articulate the role of the state in implementing suicide prevention strategies;
- to provide for training and education in relation to suicide prevention;
- to provide for the identification of priority population groups and implementing suitable initiatives to prevent suicide within such groups; and
- to provide a framework to ensure that suicide prevention response is a priority across all levels of government and community.

The Bill establishes the Suicide Prevention Council (the Council) - a statutory body that will take over the role and responsibility of the Premier's Council on Suicide Prevention.

The proposed Council will have 13 members, who will collectively have the knowledge, skills and lived experience to enable the Council to carry out its functions.

The Council's functions and powers are primarily to prepare and maintain the State Suicide Prevention Plan, to make recommendations on policies and programs intended to reduce deaths by suicide and attempted suicides and to enhance postvention responses.

The State Suicide Prevention Plan is to contain a part relating to suicide prevention among Aboriginal and Torres Strait Islander people to reflect the need to address and reduce the rates of suicide and suicide attempts in these communities.

The Bill also enables the Minister to make recommendations relating to suicide prevention.

Further, the Bill establishes a model of information sharing between certain persons and bodies and establishes the South Australian suicide register.

This Bill is unique among Australian jurisdictions and aims to set a precedent for how suicide prevention is addressed in Australia.

(8, 21, 23 September, 14 October 2021 - Act No. 51 of 2021)

SUMMARY OFFENCES (CUSTODY NOTIFICATION SERVICE) AMENDMENT

The purpose of this Bill is to amend the *Summary Offences Act 1953* to ensure that when an Aboriginal or Torres Strait Islander person has been apprehended by a police officer and delivered into the custody of a prescribed custodial officer the officer must, as soon as is reasonably practicable notify the Aboriginal Legal Rights Movement Ltd (the ALRM).

(17 June, 1 July 2020 - lapsed due to dissolution in House of Assembly)

SUMMARY OFFENCES (NOTIFICATION OF CUSTODY) AMENDMENT

The purpose of this Bill is to amend the *Summary Offences Act 1953* to ensure that when an Aboriginal or Torres Strait Islander person has been delivered into the custody of a prescribed police officer the officer must notify the Aboriginal Legal Rights Movement Ltd (the ALRM).

(17 June 2020 - lapsed due to dissolution)

TAFE SA REPEAL

The purpose of this Bill is to repeal the *TAFE SA Act 2012* for the purpose of reversing the corporatisation of TAFE and returning it to public ownership.

(23 June, 9 September 2021 - lapsed due to dissolution)

TERMINATION OF PREGNANCY

This Bill repeals sections of the *Criminal Law Consolidation Act 1935* and creates a new standalone Act to regulate the termination of pregnancy as a lawful medical procedure.

In 1969 South Australia became the first Australian jurisdiction to legislate for the lawful medical termination of pregnancy. Since then significant changes to clinical practice in this area, including improvements in medical termination methods and the modernisation of health service provision, have meant that South Australia's laws no longer reflected best clinical practice. Instead they become a barrier to healthcare access for many women and their families.

To that end the South Australian Law Reform Institute (SALRI) was invited to inquire into and report in relation to the topic of abortion law reform, with the aim of modernising the law in South Australia and adopting best practice reforms in relation to the lawful regulation of termination of pregnancy. This Bill reflects the findings of that report.

In recognising that abortion should be treated as a healthcare issue, the Bill makes it clear that a person who performs, consents to, assists in or attempts to perform a termination on themselves does not commit an offence. The Bill is informed and guided by the principles of best clinical practice and promotes and respects patient decision-making by removing a number of barriers that currently impede access to abortion care services.

(14 October, 12 November 11, 2 December 2020, 2 March 2021 - Act No. 7 of 2021)

TOBACCO AND E-CIGARETTE PRODUCTS (IMPORTING AND PACKING OF TOBACCO PRODUCTS) AMENDMENT

The purpose of this Bill is to amend the *Tobacco and E-Cigarette Products Act 1997* to increase the penalties for the importing and packing of illicit tobacco products in South Australia.

(17 November 2021 - lapsed due to dissolution)

VOLUNTARY ASSISTED DYING

This Bill provides for and regulates access to voluntary assisted dying (VAD) in South Australia.

In order for a person to access VAD under this legislation, a person must:

- be over 18 years of age, have been living in South Australia for at least 12 months, and be an Australian citizen or permanent resident;
- have requisite decision-making capacity to make and communicate a decision about VAD through a formal request process;
- have an incurable advanced disease that is causing them intolerable suffering and that will likely cause death within six months (or 12 months in the case of a neurodegenerative disease);
- have been assessed as eligible by two medical practitioners (one coordinating and one consulting) with experience in the condition causing the expected death; and
- be acting freely without any coercion.

VAD would be accessed through provision of a substance causing death which may be administered by the person themselves or by the authorised medical practitioner, depending on the circumstances.

Both the coordinating and consulting practitioners are required to advise the person making the request of alternative courses of action, such as available treatments and palliative care.

Opt-out provisions for potential facilitators of VAD have been included in the legislation for conscientious objection at both individual and institutional levels. Institutions opting out must publish information stating that fact to persons receiving services at that facility.

The legislation provides protection for medical practitioners assisting in VAD and emergency service workers attending the scene after VAD against certain provisions of the *Criminal Law Consolidation Act 1935*. It also establishes penalties for anyone attempting to coerce a person into requesting or administering VAD.

The Bill also establishes the Voluntary Assisted Dying Review Board which monitors matters related to VAD. The Board must report to the Minister annually and may report to Parliament from time to time.

(2 December 2020, 17, 31 March, 5 May, 23 June 2021 - Act No. 28 of 2021)

WALKING AND CYCLING COMMISSIONER

The purpose of this bill is to establish a walking and cycling commissioner to encourage walking and cycling as modes of travel; promote the health, environmental, social and economic benefits; and prepare and promote strategies to make walking and cycling inclusive for everybody in South Australia.

(26 May 2021 - lapsed due to dissolution)

WORK HEALTH AND SAFETY (INDUSTRIAL MANSLAUGHTER) AMENDMENT

This Bill seeks to introduce the offence industrial manslaughter into the *Work Health and Safety Act 2012*. This offence covers the situation where an individual or corporation's conduct causes the death of a worker, where that individual or corporation's recklessness or negligence caused serious harm or death to that worker. An employer is guilty of an offence if:

- the employer breaches their duty of care;
- the employer knew or was recklessly indifferent that the act or omission constituting the breach would create a substantial risk of serious harm to a person; and
- the breach causes the death of a person.

(23 September 2020, 22 September 2021 - lapsed due to dissolution)

YOUNG OFFENDERS (AGE OF CRIMINAL RESPONSIBILITY) AMENDMENT

The purpose of this Bill is to amend the amend the *Young Offenders Act 1993* and to make related amendments to the *Spent Convictions Act 2009* and the *Youth Justice Administration Act 2016* to increase the age of criminal responsibility from 10 years to 14 years.

(22 July 2020, 1 December 2021 - lapsed due to dissolution)
