 - I. Celebrates the successful cave rescue of 12 boys and their football coach trapped in the Tham Luang Cave in Chaing Rai province, Thailand;
 - II. Mourns the death of Saman Gunan, one of the Thai members of the international rescue team;
 - III. Acknowledges the key role played by Adelaide-based anaesthetist and MedSTAR doctor, Dr Richard Harris;
 - IV. Acknowledges the contribution of the Australian contingent involved in the Thai-led rescue effort;
 - V. Acknowledges the leadership and professionalism of the Thai Government and the Thai Navy Seals in effecting the rescue;
 - VI. Acknowledges the involvement and support of the international community, including support divers from the European Union, United States, and China, and participants from military and civilian organisations in various support roles;
 - VII. Recognises South Australia's proud tradition of providing emergency assistance in response to catastrophic events, such as AusMAT team member deployments to the Philippines in 2013 in response to Typhoon Haiyan, to Banda Aceh in 2004 in response to the Boxing Day tsunami, and to Bali following the bombings in 2002 and 2005; and
 - VIII. Pays tribute to the courage and dedication of South Australian health professionals in so many diverse contexts.
- 3. The Hon. F. Pangallo to move That this Council -
 - I. Acknowledges the invaluable work of pro-bono community legal centre JusticeNet in assisting many vulnerable and disadvantaged South Australians dealing with civil matters like bankruptcy, eviction and financial abuse;
 - II. Notes the decision of the State Government to decline providing recurrent funding to cover operational costs of the service has resulted in an uncertain future for JusticeNet; and

 - I. Welcomes the establishment of a National Redress Scheme and the announcement of a National Apology;
 - II. Appreciates that survivors have been waiting a long time for a National Redress Scheme and that the implementation of such a scheme is urgent and overdue;
 - III. Acknowledges the concerns that the Scheme does not fulfil all the recommendations of the Royal Commission into Institutional Child Sexual Abuse regarding the Redress Scheme;

- V. Recognises that relevant prior payments should not be indexed under the Scheme; and

- 14. Adjourned debate on motion of the Hon. F. Pangallo That this Council -
 - I. Recognises the significance of the Australian Broadcasting Corporation ("the ABC") to South Australians and especially to regional South Australians;
 - II. Acknowledges the importance of the ABC remaining a public broadcaster; and
 - III. Rejects any attempt by the Federal Government to sell the ABC (June 20, July 4) (The Hon. D.G.E. Hood).
- 15. The Hon. T. T. Ngo to move That this Council -
 - I. Recognises that all Australian job-seekers deserve adequate income support to maintain a decent standard of living and have access to resources to look for work, which enables and supports recipients to transition to paid work as soon as possible;
 - II. Supports a root-and-branch review and measures which seek to increase and enhance Newstart and other related welfare payments, which adequately addresses the current level of poverty among Australian job-seekers;
 - III. Acknowledges the work of the Anti-Poverty Network South Australia, for its advocacy in this policy area;
 - IV. Recognises that the Turnbull Liberal Government, in its most recent Federal budget, failed to address this issue and calls on it to immediately undertake a root-and-branch review; and
 - V. Recognises the last rise in Newstart occurred in 1994 under the Keating Labor Government.
- 16. Parliamentary Remuneration (Basic Salary) Amendment Bill (No. 17): adjourned debate on second reading (June 20) (The Hon J.S.L. Dawkins).¹
- 17. Adjourned debate on motion of the Hon. F. Pangallo That this Council -
 - I. Acknowledges that since 2006, concerned citizens, professionals, older people and service providers gather on 15 June each year to commemorate World Elder Abuse Awareness Day and encourages Members of the Council to wear purple to raise awareness of elder abuse;
 - II. Notes that World Elder Abuse Awareness Day recognises the significance of elder abuse as a growing social and financial concern, public health matter, and human rights issue;
 - III. Acknowledges that elder abuse comes in many forms including physical, psychological, financial, social, sexual and neglect and can be experienced in the community as well as living in an aged care facility.
 - IV. Recognises that 1 in 20 older people are the victims of elder abuse and that more research is required to tackle this critical issue;
 - V. Supports the National Plan to address elder abuse and the need for governments at both State and Federal level to work together to address violence, abuse and neglect of older people;
 - VI. Encourages governments to work with the non-government sector which provides crucial support to older people who are at risk of abuse, or who are being abused;
 - VII. Supports the implementation of adult safeguarding legislation that balances the State's duty to protect people from abuse and its duty to protect people's freedom and autonomy; and
 - VIII. Recognises that elder abuse is unacceptable in any form and that all older South Australians deserve to live a life free of violence, abuse and neglect (June 6) (The Hon J. E. Hanson).

- 18. Adjourned debate on motion of the Hon. F. Pangallo That this Council -
 - I. Acknowledges a disturbing report released by the National Wastewater Drug Monitoring Program late last year that revealed Adelaide was the methamphetamine ('ice') 'capital' of Australia, with the city found to have the highest levels of use about 80 doses per 1,000 persons per day. This compares to the national average of 30 doses per 1,000 persons per day;
 - II. Recognises the invaluable work of the Aboriginal Drug and Alcohol Council ('ADAC') in providing culturally and linguistically appropriate alcohol and other drug treatment services for both indigenous and non-indigenous clients;
 - III. Notes that ADAC is unique in Australia as it is the only Indigenous peak body of its kind representing 30 Aboriginal community organisations from across South Australia;
 - IV. Notes the services provided by the ADAC include a residential rehabilitation centre in Port Augusta and diversionary programs in Adelaide run by former AFL footballer Troy Bond, which have helped many Indigenous South Australians rebuild their lives;
 - V. Notes the Footsteps Road to Recovery program has received 350 referrals in the past two years with five former clients gaining employment and many more undertaking voluntary work in their communities;
 - VI. Recognises that up to 40 people per day undertake diversionary programs which run for 48 weeks of the year with up to 9,000 participants each year.
 - VII. Notes the Federal Parliamentary Joint Committee on Law Enforcement's final report into crystal methamphetamine published in March 2018 recommended that: "...Australian governments continue to advance collaboration with Indigenous communities and Indigenous health experts to provide culturally and linguistically appropriate alcohol and other drug treatment services";
 - VIII. Notes that this frontline drug and alcohol rehabilitation organisation faces closure because of a Federal Government funding cut; and
 - IX. Urges the Federal Government to reverse its decision to cease \$700,000 in annual federal funding to the ADAC (June 6) (The Hon. I. K. Hunter).
- 19. Petroleum and Geothermal Energy (Underground Coal Gasification) Amendment Bill (No. 12): adjourned debate on second reading (June 6) (The Hon. I. K. Hunter).¹
- 20. The Hon. K. J. Maher to move That this Council -
 - I. Recognises the importance of the reconciliation process;
 - II. Recognises this year's Reconciliation Week theme of "Don't Keep History a Mystery"; and
 - III. Commits to doing what it can in South Australian communities to encourage people to learn about Aboriginal history and culture and how we can work together to achieve reconciliation.
- 21. Petroleum and Geothermal Energy (Moratorium on Hydraulic Fracturing) Amendment Bill (No. 13): adjourned debate on second reading (June 6) (The Hon. I. K. Hunter).¹
- 22. Adjourned debate on motion of the Hon. T. T. Ngo That this Council -
 - I. Acknowledges the 50th Anniversary of the Battle of Coral-Balmoral which was fought between 12 May and 6 June 1968;
 - II. Recognises the bravery of those 3,000 Australian soldiers involved in the battles at Coral-Balmoral, and pays its respects to the 26 men who lost their lives and the more than 100 injured;
 - III. Commends the Commonwealth Government for officially recognising the gallantry of 3,000 Australian soldiers who fought at the Battle of Coral-Balmoral by awarding them a Unit Citation for Gallantry; and
 - IV. Pays special tribute to the Mothers of these fallen Australian soldiers, particularly those of the 11 men who died on the first night of the battle, which happened to be Mother's Day -(June 6) - (The Hon. J.S.L. Dawkins).
- 23. The Hon. T. T. Ngo to move That this Council -
 - I. Acknowledges the risk that instant cash loan machines present to vulnerable members in our society;
 - II. Notes the alarming trend in New South Wales where instant cash loan machines are being strategically placed in low socio-economic areas; and

- III. Encourages the Federal Parliament to introduce legislation for consideration to implement the SACC review recommendations as a matter of urgency.
- 24. Adjourned debate on motion of the Hon. K. J. Maher That this Council -
 - I. Commends Reconciliation SA and Aboriginal Veterans SA on the ANZAC Day service at the Aboriginal War Memorial;
 - II. Acknowledges the contribution of Aboriginal servicemen and women; and
 - III. Recognises that their sacrifice often did not result in equal treatment to their non-Aboriginal brothers and sisters in arms (June 6) (The Hon. J.S.L. Dawkins).
- 25. Fire and Emergency Services (Volunteer Charters) Amendment Bill (No. 4): adjourned debate on second reading (May 16) (The Hon. T. J. Stephens).²
- 26. Adjourned debate on motion of the Hon. C. M. Scriven That this Council -
 - I. Recognises International Midwives Day held on May 5th annually with the theme this year being "Midwives Leading the Way with Quality Care";
 - II. Recognises International Nurses Day held on May 12th annually with the theme being "Nurses A Voice to Lead - Health is a Human Right"; and
 - III. Thanks all midwives and nurses for the important work that they do caring for our community (May 16) (The Hon. T. J. Stephens).
- 27. Freedom of Information (Miscellaneous) Amendment Bill (No. 1): adjourned debate on second reading (May 9, July 4) (The Hon. J.S.L. Dawkins).¹
- 28. The Hon. J. S. Lee to move That this Council -
 - I. Congratulates the Royal Commonwealth Society for celebrating a special milestone of 150 years;
 - II. Acknowledges the formation and important work of the Royal Commonwealth Society South Australia Branch;
 - III. Highlights the history and significance of the Commonwealth as an association of governments and peoples, built around shared language, institutions, challenges, aspirations and values; and
 - IV. Acknowledges the role of Australia in the Commonwealth and the work by the Royal Commonwealth Society in improving the lives and prospects of Commonwealth citizens around the world.
- 29. Adjourned debate on motion of the Hon. J. S. Lee That this Council -
 - I. Raises awareness of the important role women play in agribusiness and in regional South Australia, especially in leadership roles;
 - II. Notes that women are occupying an increasing number of diverse roles in agribusiness; and
 - III. Recognises that South Australia continues to encourage more women to pursue careers in agriculture and horticulture as the world's growing demand for our food continues to rise -(June 6) - (The Hon. I. K. Hunter).
- Statutes Amendment (Decriminalisation of Sex Work) Bill (No. 2): adjourned debate on second reading (May 9, 16) - (The Hon. T. J. Stephens).²
- 31. The Hon. C. Bonaros to move -
 - I. That a Select Committee of the Legislative Council be established to inquire into and report on -
 - (a) All aspects of the 2018 State Election and matters related thereto, with particular reference to:
 - i. The operation of the funding, expenditure and disclosure scheme as outlined in the Electoral Act 1985 ('the Act');
 - ii. The operation of changes to the voting provisions of the Act;
 - iii. The application of provisions requiring authorisation of electoral material to all forms of communication to voters;
 - iv. The influence of advertising by associated entities and/or third parties who are not registered political parties during the campaign targeting candidates and political parties;

- v. The need for 'truth in advertising' provisions to communication to voters including third-party communications;
- vi. The regulation of associated entities and/or third parties undertaking campaign activities; and
- vii. The potential application of new technology to voting, scrutiny and counting.
- (b) The regulatory regime regarding donations and contributions from persons and entities to political parties, associated entities and other third parties and entities undertaking campaign activities;
- (c) The extent to which fundraising and expenditure by associated entities and/or third parties is conducted in concert with registered political parties and the applicability and utilisation of tax deductibility by entities involved in campaign activities; and
- (d) Any related matters.
- II. That Standing Order No. 389 be so far suspended as to enable the Chairperson of the Committee to have a deliberative vote only.
- III. That this Council permits the Select Committee to authorise the disclosure or publication, as it sees fit, of any evidence or documents presented to the Committee prior to such evidence being presented to the Council.
- IV. That Standing Order No. 396 be suspended to enable strangers to be admitted when the Select Committee is examining witnesses unless the Committee otherwise resolves, but they shall be excluded when the Committee is deliberating.
